

Terms and Conditions of Use of www.ampermarket.cz portal:

1. General stipulations

The owner and operator of the www.ampermarket.cz website is the company **Amper Market, a.s.**, registered address **Antala Staška 1076/33a, 140 00 Prague 4**, company ID no. **241 28 376**, incorporated in the Companies Register kept by the Municipal Court in Prague, Section B, Insert no. 17267 (the “Operator”). For the purposes of these Terms and Conditions of Use of the www.ampermarket.cz Portal (the “Terms and Conditions”), the portal shall be the web pages accessible from the address www.ampermarket.cz (the “Portal”).

The Portal shall be publicly accessible. The operation of the Portal, the rights and obligations of the Operator and users shall be governed by these Terms and Conditions. Use of the Portal shall be conditional on agreement with these Terms and Conditions. The user shall express their agreement to these Terms and Conditions through use of this Portal, i.e. by accessing the Portal and using, in any way, any information available on the Portal.

2. Authorship and usage rights

The Operator shall be authorised to exercise all property rights to the Portal pursuant to the Copyright Act (Act No. 121/2000 Coll., as amended). The Operator shall own all copyright to the content of the Portal, i.e. texts, images, drawings, graphics and software. This content may not be altered, copied, downloaded or disseminated in any other way, either independently or as part of other documents, without the prior, written consent of the Operator. This stipulation does not relate to the making of copies for private, non-commercial purposes, on condition that this does not breach the intellectual property rights of the Operator or any third parties who have granted the Operator right to the use of their works on this Portal.

3. Behaviour of the user

When using the Portal, the user must behave in accordance with valid legal regulations of the Czech Republic and these Terms and Conditions. The user also undertakes to not, in particular:

- interfere with this Portal or threaten its security and the security of other users,
- use the Portal for the dissemination of unsolicited and chain messages (known as spam),

- send messages to this Portal that contain viruses or programmes that are dangerous or otherwise harmful,
- create false messages through the falsification of the identity of the sender or attempt to infiltrate the accounts of other users of the Portal,
- attempt to gain access to parts or the Portal to which the public is not permitted access, to disseminate on the Portal messages or materials that are in breach of the legal regulations of the Czech Republic, and in particular messages or documents that interfere with the rights and justified interests of third parties, messages that go against human dignity, are of a discriminatory nature with regard to religion, race, sex or that promote violence.

4. Restrictions on the Responsibility of the Operator

The content of the Portal is of a purely informative, non-binding nature. The Operator makes no warranty for the correctness and completeness of the information contained on this Portal. The publication of any data and information contained on the Portal, with the exception of these Terms and Conditions, shall not constitute a legal transaction intended to create a legal relationship between the Operator and the user, unless explicitly stated otherwise in individual cases.

The Operator may, without prior warning, implement changes to information contained on the Portal. The user is aware of and consents to the fact that restrictions to the availability and the interruption or termination of service of the Portal may occur.

The Operator shall bear no liability for any damage that may be caused to users in relation to the use, restriction of availability, interruption or termination of operation of the Portal.

5. Links to Websites and Third-Party Advertising

The websites contained on this Portal may contain links to third-party websites. The Operator bears no responsibility for the contents of these websites.

6. Protection of Personal Data

The Operator shall be authorised to alter these Terms and Conditions at any time without prior warning.
